

Opening Session Address of the 2003 League Convention

CITIES AND TOWNS ARE NOW FRONTLINE IN HOMELAND DEFENSE

ayor Williams, Mayor Spencer, Mayor De Steano, Ladies and Gentlemen: As I stand before you this morning at the Alabama League of Municipalities' 2003 Convention Opening Session, I am honored to have served as your president this past year. I deeply appreciate the opportunities you have given me and I thank you for your confidence in me and for your friendship.

Mayor Spencer, as in years past, the hospitality of Huntsville has been outstanding. I'm sure I speak for all convention delegates and guests when I

say we are having a wonderful stay in your great city.

I also want to thank Mayor Dan Williams for his service this year as League Vice President and for the support he has given me this past year. He is truly dedicated to his community, his citizens and the League principles which guide us.

The Alabama League of Municipalities is a dynamic and growing organization. As elected officials, we are fortunate to be part of such a well-run and well maintained membership organization – one that has safe-guarded our interests since its inception in 1935. In keeping with its high standards, this past year the League endorsed several new programs to assist its members: a deferred compensation program offered through AIG-VALIC; a catastrophic insurance plan offered by Benefits of America; and a program offered by Link2Gov to assist municipalities in collecting fees through credit cards. In addition, our League has just begun sponsoring a new technical services program designed to assist member cities with cable franchise management.

There is just no way I can say enough about our executive director and his staff. Perry Roquemore never slows down. He is the strength of our organization. He continuously strives for changes in our policy and goals that



will make our cities a better place to live. I don't want to name any members of his staff by name because I might miss someone. I will just say thanks to all – you are a great and dedicated group. I appreciate your help this past year. I could not have done my job without you.

A lot has happened over the past year. The Congress of Cities held in Salt Lake City in December had a great attendance by Alabama League members. In my opinion, it was one of the best national conferences I've ever attended. Our own Cynthia McCollum, council member from Madison, was elected to the NLC Board

of Directors at the meeting. I know she will represent us well on this important body. During our NLC Congressional City Conference held in Washington, D.C. on March 9th-12th, much of the program was centered on the events of September 11th and the War Against Terrorism. The address from General Richard Myers marked the first time a major military leader had spoken to NLC delegates.

And now our great nation has just completed the battlefield portion of Operation Iraqi Freedom – a war that has already made history for its expedience. Alabama has one of the largest contingencies of National Guard, reservists and active military personnel participating in this effort. You know them. They're our sons and daughters, brothers and sisters, next-door-neighbors. In some cases, they are elected officials, police officers, firefighters, municipal employees. And while these heroes are fighting for the liberty and freedom of a dreadfully oppressed country, our cities and towns have been faced with the challenge of operating under a reduced workforce – without the expertise of key employees.

In addition, we find ourselves faced with the issue of Homeland Security. Municipalities have had to take on a direct role in what was once considered a federal responsibility. Without doubt, our cities and towns are now the frontline in homeland defense. It's been - and will continue to be - a very costly responsibility.

I am happy to report, however, that President Bush signed an emergency wartime supplemental spending bill (H.R. 1559) last week that includes \$2.23 billion in first responder assistance to local governments and states. The \$2.23 billion will be available through the Department of Homeland Security's Office of Domestic Preparedness within 60 days after the President signs the bill into law. Of the \$2.23 billion appropriated, specific allocations are as follows:

- \$1.3 billion is designated for equipment, planning and first responder training and exercises. The money will be dispersed to states; and the states must direct at least **80 percent** of the funds to local governments within 45 days of receipt.
- \$200 million is allocated for critical infrastructure protection grants where at least **50 percent** of the funds will be directed to local governments through the states, based upon the projected timeline above. The legislation permits use of the critical infrastructure protection grants for operational costs, "to include personnel overtime as needed."
- \$700 million is designated for discretionary grants to "high-density urban areas; high-threat areas; and for protection of critical infrastructure." The legislation also allows use of this funding for personnel overtime and requires that "no less than **80 percent** of any grant to a state shall be transferred ... to local governments within 45 days of receipt.

Our State Legislature is currently considering legislation to create an Alabama Department of Homeland Security to oversee our anti-terrorism efforts. The League has been working with the proponents of this legislation to ensure that municipal interests are protected.

The State of Alabama is also facing a serious and looming financial black cloud—one that could be detrimental to our cities and towns if we aren't diligent. It's estimated that 500 to 600 million dollars in *new* revenue is needed just to float the state budget. A number of proposals are being discussed to raise this necessary revenue, and it's expected that Governor Riley will call a special session to deal solely with tax reform in an effort to contain the on-going state budget crisis. As elected officials, it becomes our responsibility to make sure that—in passing new legislation and/or taxes to raise funds—the Legislature does not limit the authority of municipal leaders to generate sufficient revenue to operate our cities and towns. We must also be painstakingly steady in our efforts to ensure that money and funding belonging to municipalities *stays* with municipalities.

NLC's annual City Fiscal Conditions Survey indicated that municipalities have been hurt by the economic downturn and the surge in local homeland security spending. However, it appears that – despite the bleak forecast – our cities have survived and we continue to make progress. In fact, Shelby County, which is my county, continues to be the fastest growing county in the state. And Calera, my city, is one of the fastest growing cities. With the low interest rates, homes have continued to sell at a rapid pace.

I know each of you joins me in the on-going effort to keep our cities and towns viable – to ensure growth and stability for future generations. That's one of the very reasons we were entrusted with the offices we now hold. Therefore, we must never forget *who* we serve and *why* we serve.

We are at the midpoint of this year's legislative session. Despite the current slowdown, many League bills have received committee approval and several have passed the House of Representatives. We must continue to read our Legislative Bulletins and continue to contact our legislators on issues of vital interest.

As Aristotle once said: "We are what we repeatedly do. Excellence, then, is not an act, but a habit."

Definitely words to live by.

Thank you for allowing me to serve as your president this past year. God bless. ■

Minutes of the General Business Session

Alabama League of Municipalities Huntsville, Alabama April 29, 2003

The General Business Session of the Convention of the Alabama League of Municipalities was called to order promptly at 3:00 p.m., April 29, 2003, by President George Roy of Calera, at the Huntsville Hilton Hotel in Huntsville, Alabama. President Roy thanked everyone for their attendance at the annual business session and for their efforts on behalf of the League during the past year. He also thanked the membership for giving him the opportunity of serving as President during the past year.

The President then called upon Perry C. Roquemore, Jr., Executive Director of the Alabama League of Municipalities, for his annual report. Mr. Roquemore expressed his appreciation for the support of the officers, staff and membership during the past year. He stated that the League membership was now at 443 cities and towns and that the League finances would be adequate for fiscal year 2002-2003. Mr. Roquemore informed members as to the status of the League's 2003 Legislative Package.

President Roy then called on Mayor Leon Smith of Oxford, President of the Municipal Workers' Compensation Fund, Inc., for an annual report. Mayor Sue Glidewell of Rainbow City, Chair of the Alabama Municipal Insurance Corporation (AMIC), was then called on to make AMIC's annual report.

President Roy read the rules relating to voting at the League's business session. The President then called upon Mayor Lew Watson of Lincoln, Vice Chairman of the Resolutions Committee, for the committee's report. Mayor Watson reported that the Resolutions Committee had met on Sunday, April 27, and had recommended that the League's Proposed Policies and Goals for 2003 be adopted with the following amendment:

1. That Policy Position **H-6.8(a)** be amended by changing to word "support" to "urges".

Mayor Watson moved adoption of the Policies and Goals for 2003, as amended, which motion was seconded by Mayor Sheldon Day of Thomasville. The motion carried.

Mayor Watson then presented the resolutions for adoption. Mayor Bernard Kincaid of Birmingham requested that Resolution No. 53 be voted on separately. Mayor Watson moved adoption of Resolutions 1-52 and 54-55. The motion, which was seconded by Mayor Bobby Hayes of Pelham, carried unanimously.

Following a reading of Resolution No. 53, Mayor Watson moved adoption of Resolution No. 53, which motion was

seconded by Council President Alice Reynolds of Montgomery. The resolution was passed on a voice vote. Mayor Kincaid asked that the minutes show that he voted "no" on the resolution. A copy of all resolutions that were adopted is attached to these minutes.

President Roy then called upon Mayor Steve Means of Gadsden to present the report of the Nominating Committee. Mayor Means reported that the Nominating Committee had met and had recommended the following persons:



Director's Report League Convention, April 29, 2003

Good afternoon! In the next few minutes I want to bring you up-to-date on the operations of your League for the past year. Since we met in Mobile last April, your League officers and staff have been busy implementing new programs and trying to protect the interests of Alabama municipalities at both the national and state levels.

League Committees

The Executive Committee, presided over by our able President and Vice President, met three times during the past year and dealt with numerous issues on each occasion. On September 5th we held a very successful Committee Day at the Montgomery Civic Center. Members from all five League standing committees met with federal and state resource advisors and considered the revision of the League's Policy Statement in detail, and that statement is ready for your final consideration today. Our Polices and Goals document is very important as it is used to guide your League staff throughout the year and to assist the Committee on State and Federal Legislation when it meets each year to develop our package of League bills for introduction in the State Legislature. I want to personally thank our Committee chairs and vice chairs for their leadership and hard work. I also thank all other officials who served on our committees this year for their valuable input.

We welcome municipal officials who desire to serve on a League committee to contact the League and make your request known.

Activities With NLC

As always, the Alabama League of Municipalities was well represented at NLC meetings and activities during the past year. A large delegation of Alabama municipal officials, spouses and guests attended the National League of Cities Congress of Cities in Salt Lake City, Utah, in December. Approximately 250 delegates and spouses attended the NLC

Congressional-City Conference in Washington, D.C. last month.

The Alabama League of Municipalities is very well represented on various NLC Policy Committees and Steering Committees. At the Congress of Cities in Salt Lake, Council Member Cynthia McCollum of Madison was elected to serve a two-year term on the NLC Board of Directors. Mayor Leon Smith of Oxford and Mayor Al DuPont of Tuscaloosa serve on the NLC Advisory Committee.

Last summer your Alabama League hosted NLC's annual workshop for state league staff members. In mid July, approximately 150 state League staff members from across the U.S. attended a four-day workshop held at the Embassy Suites in Montgomery. Two members actually traveled from the Alaska League to attend this event. The meeting turned out to be one of the best ever held by the group. I am still receiving compliments from other League Directors who informed me of the positive comments made by their staff people following their visit to Alabama. The event gave us an excellent opportunity to promote Alabama.

Membership

The League's membership now stands at 443 municipalities representing over 99 percent of Alabama's urban population. Three newly-incorporated municipalities have just joined the League – Twin, Munford and Valley Grande. Although the number of participating municipalities is very high, we believe there are other small communities in our state that could benefit from League membership. We encourage officials in League member cities and towns to urge their neighbors who are non-members to join the League.

Finances, Property and Equipment

The League's finances for the current 2002-2003 budget year are expected to be adequate to meet the Executive Committee's budget that was adopted last July. Let me encourage all municipal officials to drop by your League Headquarters building anytime you are in Montgomery.

Legislative Report

Since last year's convention our state has seen the election of a new Governor and State Legislature. We also have had a number of changes in other Constitutional offices. The League staff has made contact with many of these new officials to establish a better working relationship between state government and municipal government.

The League's Committee on State and Federal Legislation, met in November and adopted the League's 2003 Legislative Package. The Regular Session began on March 4 and will end no later than June 16th. The

Constitution limits the length of a regular session to 30 meeting days within a 105 calendar day period of time. Today is the 16th meeting day of the session or the beginning of the second half of the session.

The Senate has accomplished very little during the first half of the session. Currently there is a 19-16 split in the Senate, and neither side has enough votes to pass a bill. Hopefully these differences will be worked out shortly.

The House, on the other hand, has passed a number of bills – including three bills in the League's Legislative Package. One of the passed bills would authorize the mayor to appoint two alternate members to the municipal planning commission to serve in the absence of regular members. Another bill would provide for the appointment of two new members to the State Employees Insurance Board – one from county government and one from municipal government. This Board operates the Local Government Insurance Plan which provides health insurance for a number of our members. The third bill would place ADEM in conformance with federal laws so as to eliminate many citizen lawsuits on environmental issues.

A number of other League bills have been approved by House committees and are awaiting House floor consideration. These bills include proposed legislation to improve municipal election laws, provide for mayoral participation in the State retirement system, authorize prezoning of land to be annexed into a city or town, and to authorize higher DUI and reckless driving fines.

The League has actively participated in the drafting of legislation to create an Alabama Department of Homeland Security and to make Alabama a participating entity in the Streamlined Sales Tax effort. Our efforts in both areas have been aimed at the protection of municipal interests. We anticipate a lot happening in the near future on these issues.

The League has opposed efforts to increase fees paid to county tax officials from your ad valorem tax receipts; efforts to require newly-incorporated municipalities to assume responsibility of county roads within three years of incorporation; and certain bills offered by organized labor.

We are also closely watching the tax reform effort. The state is seeking \$500 million to \$1 billion in new taxes to solve the current budget crisis. Our main concern is to make sure the fix does not adversely affect the ability of municipalities to raise revenues to pay for needed municipal services.

League Services

Your League is a service organization. In addition to our lobbying efforts and our efforts to assist municipal officials by providing information, advice and training, the League also has several programs in place to save money for our member municipalities. In the area of insurance, we offer two fine programs for our cities and towns – the Municipal Workers Compensation Fund, Inc. and the Alabama Municipal Insurance Corporation. The League, through its Municipal Revenue Service, has collected – on behalf of its members – delinquent insurance license taxes for over 65 years. We have a long distance calling program called City Net and offer two excellent computer software programs – *ALM Library* and *MunicipaLaw On Disc*. We also offer an on-line auction service called GovDeals.

This year we have endorsed several new programs to assist our members – a deferred compensation program offered through AIG-VALIC; a catastrophic insurance plan offered by Benefits for America; and a plan to assist cities and towns in collecting fees by credit cards offered by Link2Gov.

The League has just begun sponsoring a new technical services program designed to assist member cities with cable franchise management. The goals of the program are to ensure that local governments have access to the expertise required to negotiate for the benefits and services needed in our communities on reasonable terms and conditions. In return for a nominal fee, which is usually based on a city's population, cities can obtain the following services:

- Assistance in negotiating new terms and conditions for cable television franchise renewals including the preparation of the franchise documents.
- Determining companies compliance with existing franchise terms and conditions including franchise fee payment review.
- Developing and implementing a community needs assessment to determine the future cable-related needs and interest of cities.
- Assistance for electric cities in negotiating pole attachment agreements.
- Assistance in the development of public, educational and governmental channels (PEG).
- Assistance with processing request from companies to transfer an existing cable franchise.
 - Assistance with negotiating new cable franchises.
- Assistance with the development of institutional networks, if applicable.

We have contracted with Lilburn, Georgia-based Local Government Services to assist League members in providing these services. Since 1993, Greg Fender, who serves as the program's principal consultant, has assisted over 200 cities in negotiating cable television franchise renewals, transfer requests and pole attachment agreements. He has also assisted numerous cities in responding to right of way issues related to cable and telecommunications franchises. Local Government Services will provide these services in conjunction with the law firm of Moss and Barnett and with continued next page

the assistance of William F. Pohts, an engineer specializing in the emerging technologies in telecommunications and electronic systems.

We are excited about the benefits our cities can realize by participating in this program. This program will provide municipalities access to experts in the field at a very reasonable cost.

CMO Program

Our Education Program for the Elected Municipal Official, which gives every elected municipal official in Alabama to opportunity to obtain the designation of Certified Municipal Officer (CMO), continues to grow. Since the program began several years ago, we have had 2065 officials participate in the program. As of last week, 523 officials have obtained the required 40 credit hours of training for Basic CMO certification and 160 officials have earned their Advanced CMO designation. At this Convention, additional officials will earn their Basic and Advanced CMOs. The names of this year's graduates will be announced at dinner tonight. A graduation ceremony will be held in Montgomery for this year's graduates in June.

The League's Web Page has been significantly improved this year to give members another method of obtaining needed assistance. If you haven't had the opportunity, please check out our web site at **www.alalm.org**. It has quite a few features to assist League members.

Officers and Staff

Our League is recognized as one of the most successful in the country. The reason is simple – the untiring efforts of our membership. Your President and Vice President have done a super job on your behalf. Your past presidents continue to offer needed advice as we move forward. Finally, I thank my great League staff. I'll match them with any League staff in the country. Join me in thanking all of our League employees for the great job they do for us.


Looking Ahead



Tallapoosa River Named to National Endangered List

Last week, American Rivers, a national rivers protection advocacy organization, named the Tallapoosa River to its list of America's Most Endangered Rivers.

In the report, American Rivers identifies Alabama Power's R.L. Harris Dam as the chief cause for placing the river on the endangered list. Lack of flow passing through the dam is cited as the primary problem. Alabama Power states in the Birmingham News that it has been working with the Department of Conservation and others who are concerned about the fluctuating conditions of the rivers for about four years.

Stan Cook of the Department of Conservation and Brad McLane, director of the Alabama Rivers Alliance stated they are considering petitioning the Federal Energy Regulatory Commission to reopen the dam's license, if the next round of negotiations is not successful.

Wilderness Society Unveils Alabama's Mountain **Treasures Report**

Currently, only about 10 percent of the Bankhead National Forest and the Talladega Division of the Talladega National Forests is permanently protected - 41,447 acres in three Wilderness areas.

The Wilderness Society released last month a plan called "Alabama Mountain Treasures." The plan calls for additional protective measures and special designations to be placed upon 24 different areas within the Bankhead and Talladega National Forests. Some of these proposed designations include Cultural Heritage Areas, Scenic Areas, Wild, Scenic and Recreation River, Viewshed Management, Botanical

Area and Wilderness. The use of these special designations will enable the Forest Service to be more flexible in its management and more importantly target specific areas that require unique and special protective measures.

If enacted, the Wilderness Society's "Alabama Mountain Treasures" plan would provide additional protection to 139,651 acres and 75 river corridor miles within the Bankhead and the Talladega National Forests. USPIRG Profiles Sauta Cave In "Take Refuge" National Wildlife Refuge Report

Over 100 years ago, Theodore Roosevelt created the National Wildlife Refuge System. The United States Public Interest Research Group (USPIRG) celebrated this achievement by releasing a new report called "Take Refuge: Celebrating 100 Years of Threatened and Endangered Species Protection Through the National Wildlife Refuge System." Featured in the report is a chapter profiling the 264 acre Sauta Cave National Wildlife Refuge in Jackson County, Alabama. The cave/wildlife refuge, which is home to the endangered and threatened Indiana and gray bats, was recognized as a National Wildlife Refuge and habitat success story in the report. According to the report, before the creation of the refuge in 1978, as a result of habitat disturbance, the Sauta Cave (the area is an important maternity site for bats) had declined in population from a historical high of half a million bats to 128,000 in 1976. Since the establishment of the refuge more than 250,000 bats now live in the cave during peak season.

The cave is also becoming a "wildlife watching " destination with over 5000 people visiting the site a year. The attraction, witnessing at dusk and into the evening, thousands of bats exiting the cave for a night of foraging. AWF Partners with Alabama Institute for Deaf and Blind

The Alabama Institute for Deaf and Blind (AIDB) and the Alabama Wildlife Federation (AWF) has teamed up to improve wildlife habitat and aesthetics while providing job training opportunities for adults with disabilities.

Through a new program called "WildPaths", adult clients at AIDB's E.H. Gentry Technical Facility are handcrafting a line of bluebird and wood duck boxes as well as bird feeders. Once manufactured, the boxes and feeders will then be marketed through a partnership between AIDB and AWF.

The WildPaths program will give adults with special needs an opportunity to develop work skills for transition into the competitive workplace. Seed money for WildPaths came from AWF and the Alabama Power Foundation. That money will used to purchase materials and provide marketing support.

WildPaths will sell the cypress wood duck boxes for \$40 each, assembled pine bluebird boxes for \$10, unassembled bluebird boxes for \$8 and bird feeders for \$13. The products will available for purchase online at http://www.wildpaths.org. Every dollar raised through this program will be used to provide additional job training opportunities for people with disabilities.

Crab Trap Collection Day Hauls in Over 1000 Obstacles

Last month, more than 100 volunteers from numerous environmental and civic organizations turned out Saturday to help recover derelict crab traps, most of which had been blown loose during storms.

Although taking crab traps is usually illegal, cages within 500 yards of the shore were declared "marine litter" by the Alabama Marine Resources Division, for that day. Unused or defective crap traps can come loose from their anchors and cause severe damage to boats and harm and kill marine wildlife. Volunteers collected nearly 1000 obstacles and traps.

AWF Opens New Office

The Alabama Wildlife Federation has opened up its new headquarters at Lanark, in Millbrook, Alabama. VIEWPOINT

The League's Legal Department – A User's Guide

One of the League's most important functions is responding to legal inquires from its member municipalities. The League employs four full-time attorneys to provide its members with direct legal assistance when needed. While the legal department has many roles, with over 440 members – representing literally thousands of officials, employee, board members and others who may make requests – there are limits to what the department can do. This article will help readers make the most effective use of the legal department. It is intended simply as a guide, and should be read that way. Because our goal is to serve our member municipalities, League attorneys attempt to remain flexible in the services they provide.

What Services Are Available?

The legal department's primary function is to represent the interests of member municipalities throughout Alabama. Therefore, we attempt to have an attorney available by telephone every day during regular business hours. However, the Legal department is not a substitute for local legal representation. The volume of requests we receive makes individual representation impossible. Therefore, we have to restrict our activities to those which we feel best serve all our member cities and towns.

In addition to providing direct legal assistance, the Legal department provides other services, such as: preparation of amicus curiae (friend of the court) briefs in appellate cases; preparation of monthly summaries of court decisions and Attorney General's Opinions for the League magazine and the League's Law on Disc computer program; monthly legal articles in the *Alabama Municipal Journal*; drafting manuals explaining the duties and responsibilities of municipal officials and employees; providing sample and model ordinances; conducting educational and training seminars; managing the Alabama Association of Municipal Attorneys; and assisting with the League's lobbying efforts.

Who Can Inquire?

This question raises complex ethical conflicts of interest issues concerning the responsibilities of the League's attorneys. Explaining it simply, the League represents its member municipalities and not individuals, even if they are municipal officials.

The League answers inquiries from mayors, councilmembers, board members, clerks, attorneys and other representatives of member municipalities. League attorneys do not advise officials about their private legal matters. Additionally, conflict of interest rules generally prohibit us from advising members of the public regarding municipal legal matters, although we do share articles or other general information we have on hand with private citizens. Please do not encourage citizens who are not municipal officials or employees to contact the League for legal advice.

Further, the League's attorneys cannot take sides in disputes involving one municipality against another or in conflicts between municipal officials. League attorneys exercise discretion in these situations and will generally refer you to your local attorney where a potential conflict of interest appears likely to arise. If it appears that we are being asked to resolve a dispute between two or more officials, we may ask that the question be reduced to writing so that we may respond to all sides jointly. We will also make every effort to encourage cooperation on questions involving disputes between municipal officials.

How to Use the Legal Department

Whether you inquire by letter, telephone, e-mail or fax, the following guidelines will help us give you the most prompt, accurate response:

- Call or write as soon as possible after identifying your problem;
- Give us as many facts as possible. On questions involving boards, it is best to know under what section of the Alabama Code the board was created;

- If you are following up on an issue you have been discussing with one of our staff members, please advise the receptionist so that your call may be directed to that staff member;
- If you are under a deadline, let us know what it is and we will try our best to meet it;
- Municipal officials and employees are welcome to discuss matters in person at League headquarters in Montgomery. Please call in advance to make an appointment. If your questions involve a review of documents, we may ask that they be forwarded in advance of the meeting so that we may review them.

Telephone Inquiries

As noted above, the legal department's primary goal is to have an attorney available by telephone every day during business hours. Of course, there are exceptions, such as during the League's convention, or when we are trying to meet a publication deadline, or on hectic meeting days of the Alabama legislature. We try to return calls either the same or the following day and we try to give an answer over the telephone. However, not every question has a clear legal answer. In these cases, we will try to give you our best legal opinion, based on years of municipal legal experience and knowledge of state and federal laws.

Further, some questions require research before a knowledgeable answer can be given. Therefore, it is best not to put off calling until just before a deadline. Of course, not every question can be anticipated, and when a quick legal response is needed, we will make every effort to provide a speedy answer.

Written Inquiries

Because of the volume of calls, it is difficult to confirm telephone advice in writing. However, we are happy to answer written inquiries in writing and try to do so in a timely fashion. All requests for written responses should be submitted in writing, setting out the question and any relevant facts. Written inquiries are generally answered in the order received and the response time depends upon time available to draft a response. Again, we will try to accommodate a deadline, but this is not always possible. As always, it is generally best to work with your local attorney if a quick response is needed.

We generally treat faxed messages the same as written requests. A carefully written legal opinion takes just as long to prepare in either case. If you simply want us to call you back with an answer, please indicate that in your request.

E-Mail

Because of the nature of e-mail requests, they may be treated as either a written request or a telephone inquiry. League attorneys attempt to respond to electronic questions as quickly as possible, but please bear in mind that when our

attorneys are out of the office, they may not have access to a computer, which will delay any reply. If you have an e-mail question that must be answered quickly, but have not received a response, it is generally advisable to follow up with a telephone call to be sure that the message was received, and that the attorney you are attempting to reach is in the office.

Amicus Briefs

While the League does not file lawsuits on behalf of its members, we do sometimes file amicus briefs in cases on appeal to either the Courts of Appeal or to the Alabama Supreme Court if the issues involved in the case have statewide significance. If you are involved in a case on appeal and you think the Court should have input from the League, please send a written request for an amicus brief, with supporting documentation, to the legal department.

Sample Ordinances

We maintain a large supply of sample ordinances on many topics. These samples come from several sources. Our most important source for ordinances is our members. If you adopt a new ordinance, it would benefit all League members if you could forward a copy to the League legal department for our files.

Please remember that these ordinances have not been drafted by the legal department. Before using one as a guide, it is important to adapt these ordinances to your local needs and to obtain advice from your local attorney regarding compliance with statutes and case law.

We are often called upon to review ordinances or to interpret a word or phrase in an ordinance. While we can offer a cursory reading of an ordinance, we cannot be familiar with the circumstances which require the adoption of an ordinance, nor can we investigate facts which might influence the meaning of specific words. Our interpretation is not intended to be definitive and should be used merely as a second opinion for that of your local municipal attorney. He or she is in the best position to provide you with a detailed analysis of your ordinance and provide you with a final answer.

Coordination with Local Attorneys

Each municipality should have its own attorney. The League's legal department is a resource to assist your municipal needs; it is not a replacement for your municipal attorney.

Nothing we do or say is meant to interfere with the critical relationship between your municipality and your attorney. When the law is unclear or the inquiry presents substantial risk of litigation, we'll often suggest that you seek advice from your attorney, because he or she will have to represent you should you have to go to court. When your attorney provides advice, he or she does so in the belief that the recommended action puts the municipality in the most continued next page

defensible legal position. Your municipal attorney is also in the best position to know local factors which influence the need to proceed in a particular manner. Therefore, we generally encourage municipal officials and employees to follow their attorney's advice, especially on questions where the law is open to interpretation. Of course, we are always happy to discuss an issue with local attorneys, or to verify their interpretation of a statute or a case.

You should not seek our advice in the hopes that we will second-guess your attorney. We are here to assist, and not compete with, your attorney. Legal opinions are fact-specific and people who are not lawyers are often unaware of how a fact which seems unimportant to them affects the legal response. Thus, if our opinion differs from that of local counsel, we will generally advise you to follow the advice of your local attorney.

To further help municipal attorneys represent their clients, the League created the Association of Municipal Attorneys (AAMA) in 1992. AAMA provides several services to municipal attorneys. It conducts two training seminars annually for municipal attorneys, publishes updates of on-going litigation and also maintains an e-mail listserve to enable attorneys to communicate with each other on legal issues. We strongly encourage all attorneys involved in municipal representation to join AAMA. For more information, contact the legal department, or visit www.alalm.org/AAMA.htm.

Local Political Disputes

As attorneys, we answer your questions regarding municipal law. We often receive calls for "legal assistance" when the caller is seeking the resolution of a political disagreement. Every municipality has political disagreements; most cannot be resolved by looking at a statute. In many cases, statutes are subject to multiple interpretations, especially where the responsibilities and duties of municipal officials are concerned. These calls are awkward, and we cannot give you an answer about who is right and who is wrong. These disputes are best resolved in the political arena, through compromise and cooperation, rather than through legal guidance.

Coordination with Other Agencies

The League often serves as a contact point on municipal issues for other agencies, including state departments, such as the Attorney General's Office, as well as other entities, such as regional planning commissions. League attorneys often provide advice to representatives of these offices, and frequently serve as speakers at educational conferences and seminars run by these agencies. Because of our relationships with these agencies, we may refer you to one of them if we feel that they can assist you with your questions.

Relationship with the Worker's Comp Fund and AMIC

The League administers two risk-pooling type programs for municipalities—Municipal Workers Compensation Fund, Inc., and the Alabama Municipal Insurance Corporation, which provides liability coverage for municipalities. It is important to understand that the legal department does not represent these entities. We do not provide advice regarding coverage or on matters in which one of these entities has an interest. Further, following our legal advice is in no way a guarantee of coverage. Questions regarding specific coverage issues or other matters related to these entities should be directed to them, and not to the League's legal department.

Limitations

Excluded from our advisory services are matters such as:

- drafting individualized ordinance and contracts;
- comprehensive review of applications for grants or legal responses;
- on-site training for individual municipalities (although League attorneys will meet with representatives of a municipality at League headquarters if an appointment is made);
- litigation; and
- direct representation or negotiations with third parties on a municipality's behalf.

Remember.

- we cannot take sides with one municipality or one official against another;
- we generally cannot respond to questions regarding the League's worker's compensation or liability programs; inquiries on these programs should be directed to the appropriate representative.

Don't Hesitate to Call

This user's guide is not meant to discourage you from contacting the League's legal department. On the contrary, we hope that understanding the scope of our services will help you make better use of them. When in doubt about whether we can help you, please don't hesitate to call. Of course, if ethics prohibit us from responding to your question, we may have to refuse to answer your call, or may refer you to someone who does not have a conflict. We hope you will take advantage of League services and programs. If there is anything we can do to help, please let us know.

- 3. Tax Reform. Everyone has an opinion of what needs to be done to reform tax structure and law in Alabama. I hope we in the League can give advice to the Governor and Legislature that would bring about fairness and equity to our tax structure. We all realize that we operate on tax revenue. The good things that happen in our cities are paid for by taxpayers. Our aim should be to tax individuals, business and industry, sales and properties by a method that provides necessary services and does not over burden these entities.
- 4. Education. Perhaps the reform of our tax structure and laws will automatically solve the most pressing problem facing our educational system. Our crisis seems to rise and fall with the increase and decrease of tax revenue. Many counties and cities in Alabama face a bleak future because children are not being educated. We all need to work with our local school boards, our state school board, the Governor and the Legislature in order to extinguish this continual crises.
- 5. City/County Cooperation. Cooperation between cities and counties may be a relatively new thing for a lot of us who serve in government. My city and county now cooperate in solid waste disposal, animal control, jail services, facility use, land community program and projects. I am committed to carry forward strong cooperation in these and many other areas. We, as a League, need to cooperate with our County Commission Association to keep bad things from being put upon us and to solve the common problems that beset us.

I hope we can address these points in our League committees or through other methods we may devise, and be able to have a positive impact upon our state in the coming year.

The last thing I want to say to you tonight is to ask for your support for the thousands of Alabama National Guardsmen and Guardswomen, and the hundreds of Alabama boys and girls serving in the military as a career. Our boys and girls have been called to duty and will continue to be called. Those wearing the uniform, whereever they are, are in harm's way. They are placing their lives in danger to carry out the policies of our national agenda. Some from Alabama have, within the last six weeks, made the ultimate sacrifice, and we grieve for them and with their families. The world may take little note of what I say here tonight, but it should come away knowing that the Alabama League of Municipalities supports our boys and girls who serve us in the military.

We all remember September 11, 2001 – the dastardly attack upon our Nation. That was the first day of the war we now fight; and President Bush told us it would be a hard

and treacherous journey to root out the terrorists who hate the freedom and democracy that we enjoy in Alabama. But it must be done and it is being done. I remember President Bush warning the countries and nations who support and give aid to the terrorists. He said if you are for them, you are against us. Saddam is most certainly against us; but his days are numbered or may even be over. However, he must be made an example to the others – that we will not tolerate terrorism even though we are a tolerant nation. Legal Notes

COURT DECISIONS

Solid Waste: Although a municipality has the authority to maintain health and cleanliness within its police jurisdiction, the authority to regulate solid waste extends only to the corporate limits and does not extend into the municipal police jurisdiction. *Disposal Solutions-Landfill v. Lowndesboro*, 837 So.2d 292 (Ala.Civ.App. 2002).

Employees: A three judge panel of the circuit court reviewing a decision of a personnel board that affirmed the termination of a city police officer lacked jurisdiction to address the officer's claim of a conflict of interest arising from the fact that the law firm representing the city had also represented the personnel board because it presented a question of fact rather than a question of law. *Ex parte City of Homewood*, 835 So.2d 1038 (Ala. Civ. App. 2002). NOTE: The three judge panel discussed in this case is established by local law and relates only to the review of decisions of the Jefferson County Personnel Board.

Decisions from the United States Supreme Court:

Planning and Zoning: A city's submission to voters of a referendum petition seeking repeal of an ordinance authorizing construction of low-income housing and the city's refusal to issue building permits while the petition was pending implemented a facially neutral petitioning procedure and city charter provision barring a challenged ordinance from going into effect until approved by the voters and thus did not violate the 14th Amendment's equal protection clause, despite evidence of allegedly discriminatory voter statements which did not constitute state action and were not shown to be in any way attributable to city officials. *Cuyahoga Falls, Ohio v. Buckeye Community Hope Foundation*, – U.S. —, 123 S.Ct. 1389 (2003).

Decisions from Other Jurisdictions:

First Amendment: A governmental entity, when acting in a proprietary capacity under a statutory mandate to be self-sufficient, may, without violating the First Amendment, charge fees for speakers' use of distribution facilities in a nonpublic forum that exceed administrative costs tied to such use. *Atlanta Journal & Constitution v. Atlanta Dept. of Aviation*, 322 F.3d 1298 (11th Cir. 2003).

ATTORNEY GENERAL'S OPINIONS

Conflicts of Interest: A mayor who is a member of a municipal utilities board and solid waste authority, may sell real property to the utility board and solid waste authority if the board determines that the property is necessary for the utility system. However, the utilities board may not purchase the property from the mayor for the purpose of then directly selling that property to the municipality. 2003-095. NOTE: This opinion does not address the potential Ethics Law violations involved in allowing a utilities board member to sell property to the utilities board.

Jails: A sheriff or jailer, acting as an agent for an inmate, may deliver prescription drugs prepackaged by dosage to an inmate when the drugs have been dispensed by a licensed pharmacist. 2002-096. **NOTE:** This opinion modifies an opinion 2002-138 which opined that jail personnel who are not physicians, pharmacists or registered or licensed practical nurses, may not dispense or administer medications in jails.

Bid Law: When it is known or contemplated that like item purchases, including automotive parts not exempted by Section 4-16-52(a) of the Code of Alabama, involving \$7,500 or more will be made during a fiscal year, these items must be procured through competitive bid. The responsibility for

determining which items are like or similar in nature rests with the municipality. 2003-098.

Police Power: By rules adopted by the Alabama Supreme Court, the law enforcement duties of municipal law enforcement officers have been extended beyond the corporate or police jurisdiction limits for the purpose of executing search warrants addressed to them, and the statute, providing for arrest in the county within which the municipality is located, has been reaffirmed. 2003-099.

Blue Laws: Section 13A-12-1 of the Code of Alabama 1975, known as Alabama's Blue Law, is presumed to be constitutional. Enforcement of this section must be applied equally in a non-discriminatory manner. 2003-102.

Ordinances: A municipality may adopt the state law misdemeanor offense in Section 40-29-115(b) of the Code of Alabama 1975 relating to misrepresentation of residency in relation to motor vehicle registration, or it may adopt a new ordinance that is not inconsistent with the state law. 2003-110.

Officers and Offices: A cost-of-living raise is part of a person's salary or compensation and is not a benefit and therefore, a mayor may not receive cost-of-living raises during his or her present term of office. 2003-112. NOTE: Cost-of-living raises may be included in the mayors compensation for the next term of office if adopted 6 months prior to the next election as provided in Section 11-43-80 of the Code of Alabama 1975..

Donations: City officials may solicit funds from local businesses or residents to be used as matching funds for grants for improvements to the municipality. 2003-115.

Forms of Government: Local constitutional amendment establishing council-manager form of government for the City of Talledega discussed. 2003-118. NOTE: This opinion only applies to the City of Talledega.

Sales Tax: A city council has the authority to adopt a resolution to place a cap on the dollar amount of sales tax funds that the city will appropriate to the city board of education. 2003-120.

Fire Districts: Pursuant to Section 11-43-142, a city may contract to provide fire service to residents outside its corporate limits and police jurisdiction. 2003-125. NOTE: This opinion discusses Shelby County Fire Districts as established by local constitutional amendment.

League Remembers Ben Carlton

Organist Ben Carlton, who had performed at the League's annual convention for more than 20 years, died March 31, 2003, after a long battle with cancer. He was 71.

Ben was born on April 9, 1931 at the Carlton Family home in Coosa County. He received a BS in Music Education from Jacksonville State College and a MA from the University of Alabama in 1960.

After teaching one year at Clay County High School, Ben was drafted into the US Army in 1954. He served two years as a chaplain's assistant, the last year at Ft. McClellan, Alabama. During this time he also served as choir director at the Central Presbyterian Church in Anniston. Following his honorable discharge in 1956, he married Joyce Ann Silar, of Anniston, on August 28.

Primarily a band and choral teacher, Ben taught in several school systems, including 12 years in the Sylacauga system. He retired in 1983 after serving seven years as the director of the first Coosa County School Band.

A life-long Presbyterian, Ben had served as choir director and organist for a number of churches and spent more than 20 years serving in the Goodwater United Methodist Church. He was also a horse show organist and played in 12 states. In addition he was the organist for the Alabama Cattleman's State Convention and the Alabama League of Municipalities' Annual Convention. Ben was also President of the Coosa County Historical Society and became a genealogist in the process.

He is survived by his wife, his daughter and his granddaughter. ■





ERS Board of Control Elections

The positions to be filled are: (1) Active Local Employee position and (2) Retired State Employee position. The Active Local Employee position represents active, contributing members employed by any agency such as a city, county, or town. These are not state agencies. The Retired State Employee position represents retired members of state agencies who are currently receiving a retirement benefit.

Election ballots will be mailed by June 2 to ERS retired state members and ERS local active members at their home address. If you do not receive a ballot, please contact the elections coordinator at 1-800-214-2158, extension 573.

This is an important opportunity to select a fellow member to work on the important business of governing your retirement system for the next four years. The members who serve on the Board of Control are vital to the ERS and its members. They are the trustees for the retirement funds and are responsible for the management and administration of the retirement system.
