OPENING SESSION ADDRESS OF THE 2008 LEAGUE CONVENTION

By Mayor Sonny Penhale, Helena Immediate Past President

Mayor Duran, Mayor Langford, Councilmember McCollum, Chief Justice Cobb, Ladies and Gentlemen, I am honored to stand before you this morning for the Opening Session of our 2008 annual convention. It has been a privilege to have served as your president this past year. I appreciate the opportunities you have given me and I thank you for your confidence, your support and your friendship.

Mayor Langford, the hospitality of the Magic City has been exceptional. I want to personally thank you, the Birmingham City Council and your staff for welcoming us with open arms.

I also want to thank Mayor Melvin Duran of Priceville, who

has represented us well as our League Vice President this past year. Melvin is a long-serving, dedicated mayor. The citizens of Priceville are fortunate to have him at the helm.

We certainly thank Chief Justice Cobb for being with us this morning. Her schedule is no doubt quite busy this time of year. Thank you, also, to Councilmember McCollum, who is the first elected official from Alabama to become President of the National League of Cities. She has been an outstanding representative of not only Alabama, but municipal officials throughout the country. Please join me in honoring Cynthia with a round of applause for a job well done!

This has truly been a rewarding year. It has been my honor to represent municipalities in Alabama as I have traveled with League staff to meetings in Natchez, Mississippi, New Orleans, Washington, D.C. and Wilmington, North Carolina. My tenure as president of the League has deepened my respect for Perry Roquemore and his entire staff. Our League is highly respected by NLC and our sister leagues and we are fortunate to have an organization representing our interests that is so well managed and professionally staffed.

Throughout my years of public service, this year as your League president stands out as one of the most memorable. Γve had the opportunity to make new friends, encourage old ones and work to impact legislation benefiting local government.



Tonight, the 2008 Regular Session of the Alabama Legislature will conclude. Although very few statewide bills have been enacted this session, two bills strongly supported by our League have already passed. Six other bills in the League's legislative package need only a vote in the State Senate and could receive final passage before the legislature adjourns today.

This session, the league has monitored approximately 350 statewide bills which, if enacted, would impact municipalities. Most of the bad bills have already been defeated or amended through our lobbying efforts. I want to thank our league lobbying team for their

hard work during a very frustrating session. I also want to thank all municipal officials who made contacts with their Senators and Representatives on many of these bills. Your action helped us greatly.

In my 41 years of service as a municipal official, I cannot remember a more crucial time for our cities and towns. Fuel costs are at a record high and are expected to increase over the summer. As you well know, increased fuel costs will affect our municipalities in many ways. The cost of operating city vehicles for garbage collection, police protection and fire protection will increase. If fuel consumption decreases, our city gasoline tax dollars, which are used to fund city services, will also decrease. Higher fuel costs will also affect tourism and result in less sales and lodgings tax revenues for our municipalities. With less revenues and higher service costs, we as elected officials will be called upon to make very important decisions on whether to cut services or to find additional revenues to pay for these services.

I also question whether our State Legislature and Congress have forgotten the important role municipal government plays in today's society. Many of the day-today services enjoyed by our citizens are the **direct result of city government** – not state or federal government. Local government provides police protection, fire protection, utility



DEADLINE to participate: December 1, 2008

Governor Bob Riley invites you to celebrate your town in 2010 by participating in the statewide promotion of The Year of Alabama Small Towns & Downtowns.

- Invite former residents back for a special Homecoming Weekend.
- · Unveil a locally written historic marker on the history of the town.
- . Lead a walking tour of the historic area.
- Dedicate a completed civic project, such as a new park or restored landmark building or other needed public project.

The Alabama Tourism Department will publish an attractive book that features photographs and a brief history of each participating municipality. The books will be sold in stores all over Alabama. Each participating municipality will also receive a free, custom historic marker. Submit your 2010 celebration date by the deadline of December 1, 2008 to be certified as an official "Year of Small Towns and Downtowns" participant.

The Homecoming Weekend:

If you have a popular annual event, declare that date in 2010 to be your community's Homecoming Weekend and make it even bigger. If your city or town doesn't have an annual event, you need one and this is the perfect way to start. When your committee does the event once, you'll discover how easy it is to repeat the following year.

Who is sponsoring The Year of Small Towns and Downtowns? The Office of the Governor, The Alabama League of Municipalities, The Alabama State Chambers of Commerce and the Alabama Tourism Department.

What will it cost us to participate? Nothing. There is no administrative fee. The primary costs would be for a civic project of your choosing.

Do we absolutely have to do "a civic project"? No.

Does this require a local committee or can this project be done through the mayor's office? That decision is up to the town government.

What action is expected of the council or the chamber? Approve a resolution before Dec. 1, 2008, declaring that the municipality (or chamber) will host a homecoming celebration on a particular date in 2010 inviting previous residents to return home.

Who is responsible for the free historic marker? Alabama Tourism will order it and pay for it. Your committee will write the text. Approximately 150-175 words per side is suggested. The second side can be a continuation of the first side, or it can be a completely different subject. The text for the marker is due on or before December 1, 2008. The completed marker will be shipped from the factory to the mayor. When you send the text, include a note with the DATE in 2010 of your Homecoming Weekend in which you intend to dedicate the marker. This way we will have enough time to have it made.

Why does this have to be done by December 1, so far in advance? The preparation of the book and manufacture of a large number of historic markers will take a full year.

What is the deadline for sending the words for the marker to the Alabama Tourism Department? December 1, 2008

Who do we contact? Where do we send our text to for the historic marker? Email the name of your committee chair, the contact's personal email address and send questions to Brian Jones at the Alabama Tourism Department in Montgomery. Contact: Brian. MINUTES OF THE GENERAL BUSINESS SESSION

ALABAMA LEAGUE OF MUNICIPALITIES

BIRMINGHAM, ALABAMA, MAY 20, 2008

The General Business Session of the Convention of the Alabama League of Municipalities was called to order promptly at 2 p.m., May 20, 2008, by President Charles W. "Sonny" Penhale, Mayor of Helena at the Birmingham-Jefferson Convention Complex in Birmingham, Alabama. Mayor Penhale thanked everyone for their attendance at the annual business session and for their efforts on behalf of the League during the past year. He also thanked the membership for giving him the opportunity of serving as president during the past year.

The president then called upon Perry C. Roquemore, Jr., Executive Director of the Alabama League of Municipalities, for his annual report. Mr. Roquemore expressed his appreciation for the support of the officers, staff and membership during the past year. He stated that the League membership was now at 443 cities and towns and that League finances would be adequate for fiscal year 2007-2008. He also discussed the recently completed legislative session and numerous League services and programs.

President Penhale then called on Mayor Leon Smith of Oxford, President of the Municipal Workers' Compensation Fund, Inc., for an annual report. Mayor Bobby Payne of Tallassee, Chair of the Alabama Municipal Insurance Corporation (AMIC), was then called on to make AMIC's annual report. Mayor Roy Dobbs of Berry, Chair of the Alabama Municipal Funding Corporation (AMFund) was called upon to make the AMFund annual report.

The President then called upon Councilmember Charles Woods of Childersburg, Chair of the Resolutions Committee, for the committee's report. Councilmember Woods reported that the Resolutions Committee had met on Saturday, May 17, and had recommended that the League's Policies and Goals for 2008 be adopted with the following amendments:

- 1.Amend Policy Position F-8.1 to read as follows: "F-8.1. That restrictions be enacted to prevent incorporation of new municipalities with fewer than 500 inhabitants within the police jurisdiction of an existing municipality."
- That a new Policy Position P-1.10 be added to read as follows: "P-1.10. That the League urges Congress and the Alabama Legislature to enact tougher laws against identity theft."
- 3. That Policy Position H-2.4 be amended to read as follows: "H-2.4. That the League supports adequate funding to maintain the Community Services Block Grant program in all 67 counties. Further, all funds should stay with the

Community Action Agencies."

Councilmember Woods moved adoption of the Policies and Goals for 2008, as amended, and the motion was seconded by Councilmember Mack Arthur Bell of Roanoke. The motion carried.

Councilmember Woods then presented the resolutions for adoption. He pointed out that members were given summaries of 55 resolutions recommended by the Resolutions Committee. Councilmember Wood moved adoption of Resolutions 1 through 50. The motion was seconded by Councilmember Ed Carroll of Orange Beach. The motion was adopted.

Council Membermoods moved adoption of Resolution No. 51 honoring Mayor Charles W. Sonny Penhale for his service as League President. The motion, which was seconded by Councilmember Ed Scott of Adamsville, passed unanimously.

Councilmember Woods moved adoption of Resolution No. 52 memorializing former League General Counsel Robert C, "Bobby" Black. Mayor James Byard of Prattville seconded the motion. The motion passed unanimously.

Councilmember Woods moved adoption of Resolution No. 53 memorializing former League loss control employee Robert Jason Humphries. Mayor Rena Hudson of Warrior seconded the motion. The motion passed unanimously.

Councilmember Woods moved adoption of Resolution No. 54 memorializing former League President George Van Tassel of Tuscaloosa. Councilmember Robert Earnest of Winfield seconded the motion. The motion passed unanimously.

Councilmember Woods moved adoption of Resolution No. 55 memorializing active and former officials who have passed away since the last League convention. Councilmember Henry Barnes of Bayou La Batre seconded the motion. The motion passed unanimously.

The President then called upon Mayor Bobby Payne of Tallassee to present the report of the Nominating Committee. Mayor Payne said the Nominating Committee had a tough assignment choosing officers for the next year from an abundance of very qualified candidates. He reported the Nominating Committee had met and had recommended the following persons:

services, garbage collection, zoning and planning as well as many other services needed by our citizens.

In my opinion, it has become much more difficult to pass legislation to help municipalities provide these services. We are also being called upon each year to fight an increasing number of bills at both the federal and state levels that would diminish our ability to provide these and other services. This year, we saw bills introduced at both the state and federal levels requiring cities to collectively bargain with union representatives over wages, benefits and other conditions of employment for certain employee groups. These bills could have resulted in the decision-making power as to wages and conditions of employment of city employees being take away from elected city officials and given to outside arbitrators.

We also faced bills to limit municipal powers to regulate the placement of cell towers and billboards, and to limit the ability of a city council to determine all the provisions of its local building code. These are but a few examples. The list goes on and on.

Many of our state and federal legislators recognize the important role played by municipal government. I call upon the rest to become reacquainted with the important role played by cities and towns and to refrain from introducing legislation which would make it much more difficult to protect our citizens.

We are blessed to have an organization such as the Alabama League of Municipalities to protect our interests at the Legislature and to give us legal advice on the many challenges we face daily. In November we will see a large number of new faces entering into municipal government for the first time. It is important that these individuals become aware of our League and the services provided as soon as possible. Our League has accomplished many great things since its creation in 1935 – and through our united efforts, this list of accomplishments will continue to grow.

I'll close by thanking the members of the Helena City Council and all the City staff. They have graciously allowed me serve you this year, and have always supported me and our League. Again, I thank you for the privilege of serving as your League president. May God bless you and your communities. •

Municipal Overview

Director's Report – 2008 Convention May 20, 2008



Perry C. Roquemore, Jr. Executive Director

The last 13 months since our convention in Huntsville have been very busy for the League and League staff. Since we met in Huntsville last year, your League officers and staff have been implementing new programs and trying to protect the interests of Alabama municipalities at both the national and state levels.

League Committees

The Executive Committee, presided over by our able President Sonny Penhale, met three times and dealt with a number of issues. Our five policy committees met on separate days at League Headquarters in Montgomery to hear resource advisors speak on issues of importance to each committee. Following the presentations, the committee members revised their respective policy statements, which will be presented for your approval this morning. This Polices and Goals document is very important as it is used to guide your League staff throughout the year and to assist the Committee on State and Federal Legislation when it meets each year to develop the League's legislative package. I want to personally thank our Committee chairs and vice chairs for their leadership and hard work. I also want to thank all the officials who served on our committees this year for their valuable input. Would all officials who served on League policy committees this year please stand so that we can all applaud you for your efforts? As I like to do each year, I would encourage any of you who did not serve on a League committee this year to let us know if you would like to serve. We would love to have your involvement and ideas.

NLC Activities

The Alabama League of Municipalities continues to be well represented at NLC meetings and activities during the past year. The League had one of the largest state delegations at the National League of Cities Congress of Cities in New Orleans, Louisiana, in November, and at the NLC Congressional-City Conference in Washington, D.C. in March. At the November meeting in New Orleans, our own Cynthia McCollum, took over the leadership of NLC. Mayor James Perkins of Selma joined Mayors Leon Smith of Oxford and Ted Jennings of Brewton on the NLC Advisory Committee. Councilmember Debbie Quinn of Fairhope was elected to serve on the NLC Board of Directors. Numerous other Alabama officials represent us well on NLC steering committees and policy committees, and the NLC Small Cities Council. I ask that all Alabama officials who serve on NLC boards and committees to stand and be recognized.

Membership

The League's membership now stands at 443 municipalities out of the 460 in the state representing over 99 percent of Alabama's urban population. Although the number of participating municipalities is very high, we believe there are other small communities in our state that could benefit from League membership. We encourage officials in League member cities and towns to urge their neighbors who are non-members to join the League.

Finances, Property and Equipment

The League's finances for the current 2007-2008 budget year are expected to be adequate to meet the Executive Committee's budget that was adopted last July. We have continued the expansion of our League IT Department by adding a third IT specialist to our staff. Since the last convention, the League IT staff has added several new discussion forums and continued the conversion of our information into a digital format. We have also recently replaced our aging phone system with a new state-of-the-art VOIP phone system. We continue to spend a lot of time and effort to insure that our data is completely and accurately backed up and that the security of our system is top notch.

We also continue to produce audio courses for our CMO Program as well as video productions for training purposes. Our latest video production was shown Sunday afternoon to

LEGAL CLEARINGHOUSE

NOTE: Legal summaries are provided within this column; however, additional background and/or pertinent information will be added to some of the decisions, thus calling your attention to the summaries we think are particularly significant. We caution you not to rely solely on a summary, or any other legal information, found in this column. You should read each case in its entirety for a better understanding.

ALABAMA COURT DECISIONS

Ad Valorem Taxes: Status of facilities as nonprofit charitable organizations exempt from federal income taxation did not automatically exempt them from ad valorem taxation. Surtees v. Carlton Cove, Inc., 974 So.2d 1013 (Ala.Civ. App.2007)

Annexation: A city's annexation of property where a gas station was located was valid, where the map was located in a file on the chief probate clerk's desk and at least one person was furnished the map by the office staff after asking to see it. The annexation map was open to inspection during the public notice period of the annexation statute as was required for annexation. Russell Petroleum, Inc. v. City of Wetumpka, 976 So.2d 428 (Ala.2007)

Courts: Defendants on probation are entitled to due process before their probation is revoked. The procedures for probation-revocation proceedings are set out in Rule 27.5 and Rule 27.6 of the Alabama Rules of Criminal Procedure. A defendant can assert for the first time on appeal that the court violated his due process rights in revoking his probation. Andrews v. State, 975 So.2d 392 (Ala.Crim.App.2007)

Courts: Counsel's preventing defendant who wanted to testify from testifying on his own behalf was ineffective assistance of counsel. Reeves v. State, 974 So.2d 314 (Ala.Crim.App.2007)

Schools: A Juvenile Court referee's order dismissing a father's action against a school board was not a final, appealable order, in the absence of confirmation by a judge or rehearing by a judge as required by §12-15-6 of the Code of Alabama, 1975. C.P. v. Fairfield Board of Education, 975 So.2d 982 (Ala.Civ.App.2007)

Taxation: An out-of-state railcar company did not derive income from sources within Alabama, and thus, it was not subject to Alabama income tax, even though some of its leased railcars were stored in Alabama. State Department of Revenue v. Union Tank Car Company, 974 So.2d 1024 (Ala.Civ.App.2007)

Taxation: A flat tax applied to vehicles moving in interstate commerce discriminates against out-of-state vehicles by subjecting them to a much higher charge per mile traveled in the State, and does not purport to approximate fairly the cost or value of the use of the State's roads. A state may tax an activity in interstate commerce if: (1) there is a substantial nexus between the activity and the taxing state; (2) the tax is fairly apportioned; (3) the tax is nondiscriminatory; and (4) it is reasonably related to services and protection provided by the taxing state. Boyd Bros. Transp., Inc. v. State Dept. of Revenue, 976 So.2d 471 (Ala.Civ.App.2007)

Zoning: A municipal board of zoning adjustment has a statutory duty to transmit a transcript of proceedings regarding variance to the trial court upon neighboring landowner's timely filing of a written notice of appeal with the board. Carter v. Prattville Bd. of Zoning Adjustment, 976 So.2d 459 (Ala.Civ.App.2007)

UNITED STATES COURT DECISIONS AFFECTING ALABAMA

Searches and Seizures: An arrest by state law enforcement officers for an offense for which state law does not authorize an arrest is not an "unreasonable" seizure for Fourth Amendment purposes. Police officers did not violate the Fourth Amendment by arresting a motorist whom they had probable cause to believe had violated a Virginia law by driving with a suspended license, even though, as matter of Virginia law, this misdemeanor offense of driving with a suspended license



was one for which, under particular circumstances of motorist's case, officers should have issued summons rather than made arrest. Virginia v. Moore, — S.Ct. —, 2008 WL 1805745 (U.S.2008)

DECISIONS FROM OTHER JURISDICTIONS

Drug Forfeiture: Sovereign Immunity does not bar a claim against the government for interest on wrongfully seized money. Carvajal v. U.S., 521 F.3d 1242 (9th Cir.2008)

Labor Decisions: An energy utility did not violate the Fair Labor Standards Act by not paying its lineman for time when they might be called out to perform emergency work. "An employee who is not required to remain on the employer's premises but is merely required to leave word at his home or with company officials where he may be reached is not working while on call." Jonites v. Exelon Corp., --- F.3d ---, 2008 WL 879839 (7th Cir.2008)

Tobacco: An Austin, Texas, ban on smoking in enclosed public places is not unconstitutionally vague in requiring places such as bars and restaurants to take "necessary steps" to prevent patrons from smoking. Roark & Hardee LP v. City of Austin, --- F.3d ---, 2008 WL 819509 (5th Cir. 2008)

ATTORNEY GENERAL'S OPINIONS

Community Notification Act: The Sex Offender Registration Act does not apply to persons who are adjudicated as youthful offenders. The Alabama Community Notification Act, however, places certain registration and verification requirements upon juvenile and youthful offenders. AGO 2008-071

Courts: Restitution owed a defendant as a victim in another case may be withheld to pay restitution the defendant owes under section 15-18-140, et seq., of the Code of Alabama. AGO 2008-075

Elections: Section 17-4-32 of the Code of Alabama does not authorize the Secretary of State to provide a current statewide voter list without charging the uniform fee required by section 17-4-38 of the Code. AGO 2008-066

Elections: If a person's name does not appear on the voter registration list for the precinct where he or she is attempting to vote, an election official should not add the voter's name to the official voter registration list at the polling place,
and the voter should not be allowed to vote except as follows: If the voter presents a certificate of verification from the
board of registrars or the election official receives verification by phone that the voter is entitled to vote at that precinct,
the election official and the voter must complete the verification form, and the voter may cast a regular ballot. If this
verification is not provided, the voter may cast a provisional ballot. AGO 2008-067

Education: The position of a chief school financial officer may be funded under the state Foundation Fund Program. Pursuant to section 16-22-13.5 of the Code of Alabama, chief school financial officers are entitled to the state-mandated raise. AGO 2008-068

Fire Districts: Fire Protection Districts organized pursuant to Act 79 (1966), as amended, are not exempt from motor fuel and gasoline excise taxes. AGO 2008-07 Note: This opinion overrules AGO 2005-162. Act 79 (1966) applies only to Jefferson County.

Public Records: Time sheets of employees in the Revenue Commissioner's Office are public records. Certain sensitive information, however, that may be contained in those records is not public record. The custodian of records should redact sensitive personnel information. The custodian of records may recover the reasonable cost involved in providing the requested records to a citizen. The custodian of records must make the records available for copy and inspection during the normal business hours, within a reasonable period of time that the request was made, and may do so in such a manner as to "prohibit work disruption." AGO 2008-073

honor our 2008 Achievement Award winners.

Let me encourage all municipal officials to drop by your League Headquarters building anytime you are in Montgomery.

League Services

The League exists to serve its member cities and towns and their officials. In addition to our lobbying efforts and our efforts to assist municipal officials by providing information, advice and training, the League also has several programs in place to save money for our member municipalities. These include the Municipal Workers Compensation Fund for workers compensation insurance, the Alabama Municipal Insurance Corporation for liability and property insurance, the Alabama Municipal Funding Authority or AMFund for your financing needs, the Municipal Revenue Service program for collecting delinquent insurance license taxes and our computer software programs — the ALM Library and Municipalaw on Disc.

The League continues to endorse a number of outside programs to benefit our members such as the Gov Deals online auction service, the Revenue Recovery Program, the Cable Television Franchise Management Service, the Model City Ordinance Review Program, the Automated External Defibrillator Program (AED), U.S. Communities purchasing program and CGI Streaming Video.

If you need any of these services, I recommend you contact the League or the endorsed providers. Most of them had displays in our tradeshow. Information on these programs can also be found on the League website.

During the coming year, the League officers and staff will continue to look at new and innovative programs to assist our member municipalities.

Legislative Program

The 2008 Regular Session ended last night in Montgomery. The League Committee on State and Federal Legislation, led by its Chair, Council Member Charles Woods of Childersburg, and its Vice Chair, Mayor Bobby Bright of Montgomery, met in November and adopted an ambitious League Legislative Package for the 2008 Regular Session. In spite of the fact that very few bills were passed this session, six bills in the League package were up for final passage on the last day. Two other measures strongly supported by the League were also passed. A full report on the 2008 Regular Session will be posted on the League's website at the end of the week.

CMO Program

Our Education Program for the Elected Municipal

Official, which gives every elected municipal official in Alabama the opportunity to obtain the designation of Certified Municipal Officer (CMO), is completing 13 years. Since the program began, we have had 2832 officials participate in the program. As of last week, 781 officials have obtained the required 40 credit hours of training for Basic CMO certification and 326 officials have earned their Advanced CMO designation. At this Convention, additional officials will earn their Basic and Advanced CMOs. The names of the 2008 graduates will be announced during today's closing luncheon. A graduation ceremony will be held in Montgomery this summer.

Publications and Information

The Alabama Municipal Journal continues to be one of the country's best municipal publications. The League's website continues to be improved to give members another method of obtaining needed assistance. We are getting a tremendous amount of hits to our site together with many compliments on it. If you haven't had the opportunity, please check out our website at www.alalm.org. It has quite a few features to assist League members.

Legal Services

Our Legal Department continues to provide top notch legal assistance to our members. Last year, over 8,000 of your inquiries were fielded by our legal team. In addition to answering your legal questions, they also provide two training workshops annually for city attorneys and are in constant demand to speak at meetings for lawyers and nonlawyers throughout the state. Our legal staff also prepares monthly articles for the website and the Alabama Municipal Journal.

League Staff

League employees are assigned to work in one or more of the followings areas or departments – Legal and Research, Finance, Legislative, Communications, Member Services, CMO, IT or Insurance. Although I am biased, I am certain that I have the best staff in America. These extremely competent people provide excellent service to our members on a daily basis. Please join me in thanking them for a job well done.

On a sadder note, this year we lost two individuals who gave many years of service to your League. Jason Humphries was an outstanding member of our Loss Control team until his unexpected death last November. Bobby Black, who passed away in March, served the League as General Counsel for many years. Both will be missed.

Looking Ahead

Our League continues to be one of the most successful in the country. The reason is simple – the untiring efforts of our membership. Your President and Vice President have done a super job on your behalf. Your past presidents continue to offer needed advice as we move forward.

The next year will be full of challenges for municipalities. Most of our cities and towns will hold elections in August and October and new administrations will assume office on the first Monday in November. We will lose many dedicated officials through retirement. Hopefully, the voters will elect new officials to replace this great loss of experience and know-how. 
