BIDDING REQUIREMENTS:

- 1. A certified check or bond payable to the City of Greenville for not less than five percent (5%) of the bid amount, not to exceed \$10,000.00, must accompany each proposal.
- 2. Workmen's Compensation, public liability and property damage insurance, Performance, Labor and Material Bonds will be required.
- 3. Bid must be submitted on proposal form furnished by the City at the date, time and place indicated.
- 5. All bidders bidding in amounts exceeding that established by the State Licensing Board for General Contractors must be licensed under the provisions of Title 34, Chapter 8, Code of Alabama, 1975, as amended, and must show evidence of license before bidding or bid will not be accepted or considered. All bidders shall show evidence of State Licensing Board General Contractors License by including current license number on the outside of the sealed envelope in which the proposal is delivered. Bidder must also include his or her current license number on the proposal form. No bid may be withdrawn within 60 days following the bid opening.
- 6. The City of Greenville reserves the right to reject any or all proposals and to waive technical errors if, in their judgment, the best interests of the City will thereby be promoted.
- 7. Contractor shall be responsible for all construction signage and traffic control. The contractor shall provide and maintain lighted barricades and warning signage for all potentially hazardous situations, drop-offs, structures or exposed utility sites created during milling until street is resurfaced.
- 8. Job will begin within fifteen (15) days after acceptance of "Notice of Award" and be completed within ninety (90) calendar days. Construction dates must be coordinated with Public Works Director in advance so proper notice may be given to residents.

GENERAL BID SPECIFICATIONS:

- Bid includes milling, cleaning, and asphalt surface for city streets as listed. Per-ton price should include asphalt, hauling, cleaning, and driveway stub-outs no longer than three (3) feet. All driveway stub-outs are to be constructed simultaneously with street resurfacing (not after paving has been completed).
- A variable milled surface is required on this project. Edge of milled surface at the gutter should be six inches (6") below top of curb. Milled surface at centerline of roadway shall be 1½ - 2 inches below existing surface. Milled surface cannot be exposed more than fifteen (15) days.
- 3. City will retain millings with contractor providing transportation of millings from construction site to the City's storage site on Landfill Road.

- 4. Unit price governs.
- 5. Tack coat is required and should be included in per-ton price.
- 6. Asphalt price adjustment is not applicable to this project.
- 7. Payment to be made on quantities placed.
- 8. Cleaning and tacking of all area to be resurfaced is required.
- 9. Contractor will be required to remove all loose asphalt from curb and gutter upon completion of project.
- 10. Contractor will be required to clear project area of all trash and debris upon completion.
- 11. City shall be provided a copy of all daily load tickets for the project signed by the City's designated project inspector or Public Works Director.

PAVING NOTES:

- 1. List of city streets to be included in project is attached for contractor's reference.
- 2. Overlay resurfaced area with 165 lbs. of ALDOT standards ½" surface mix asphalt.
- 3. Leveling of asphalt to be determined by Public Works Project Inspector using 416-A 1/2" surface mix asphalt.
- 4. There are THIRTY EIGHT (38) manholes, SIXTEEN (16) water valves, and NINETEEN (19) gas valves. Outer edge of manholes shall have approximately 12" x 4" lip of 3,000 lb. concrete mix with wire. Project inspector will determine necessary adjustments on manholes and water and gas valves.
- 5. All driveway stub-outs, where necessary, are to be paved an average of three (3) feet. Construction of driveway stubs should take into consideration drainage and clearance.
